# Criminal charges filed against Swissmedic

**Zurich, November 14, 2022 – On July 14, 2022, six people who were allegedly injured by mRNA vaccinations and other people filed criminal charges against the Swiss licensing authority Swissmedic and vaccinating doctors. They accuse the reported persons, among other things, of serious and lasting violations of basic pharmaceutical law due diligence obligations. A first cantonal criminal case against vaccinating doctors has already been opened. The criminal complaint comprises around 300 pages and can be viewed online together with the scientific evidence (evidence report; around 300 pages; plus 1,200 pieces of evidence). The presumption of innocence applies to everyone involved. By going public, the plaintiffs want to prevent even more people from being harmed by the novel and harmful mRNA vaccines.**

Based on extensive investigations by a large team of lawyers and scientists, there is an allegation that Swissmedic has created a risk to public health through the aforementioned legal violations that significantly exceeds that of SARS-CoV-2 and thus the health damage to an indefinitely large part accepted by the Swiss population. **The persons reported by Swissmedic are responsible for the following misconduct relevant to criminal law (not exhaustive):**

- **Swissmedic authorized the novel medicinal products even though the minimum requirements required by law were never met (Art. 7; 9a TPA);**
- **Swissmedic failed to adequately minimize the significant risks associated with the authorization of these products and to effectively protect the health of consumers (Art. 3 TPA);**
- **Swissmedic misled the public about the actual risk/benefit ratio by providing incomplete and explicitly untrue information (Art. 1 para. 2 lit. a and 3 TPA).**

After the competent authorities have remained largely passive since the criminal complaint was filed exactly 4 months ago, the responsible lawyers today presented the criminally relevant facts and the results of their comprehensive investigation work to the media. In the criminal complaint they justify their allegations in detail. They show that the responsible persons at Swissmedic have seriously and permanently violated their duty of care in relation to medicinal products, with serious consequences for the health of young, healthy people and the entire population.

The corresponding violations of the law concern both Art. 9a of the Therapeutic Products Act (HMG), which regulates the temporary approval of medicinal products (and thus also applies to mRNA vaccines), as well as the requirement laid down in Art. 1a HMG to protect consumers from deception protection. According to Art. 3 HMG, Swissmedic is obliged to take all measures to ensure that people's health is not endangered. To do this, it must record risks regularly, systematically and with foresight. In addition, according to Art. 7 HMG, Swissmedic must ensure that no products are released whose quality, safety and effectiveness have not been proven. violated



If the responsible persons at Swissmedic breach these elementary duties of care, they are liable to prosecution under Art. 86 TPA.

### Minimum legal requirements never met (Art. 7; 9a TPA)

Contrary to the public announcements by Swissmedic, the mandatory legal requirements regarding quality, effectiveness and safety of the mRNA "vaccines" were never met. The manufacturers' approval studies do not show that the vaccines are effective in reducing transmission, nor that they can prevent serious illnesses or deaths. The statements made by Swissmedic on the alleged reduction in "severe Covid diseases" are based only on data from four initial cases (BioNTech/Pfizer), resp. 30 cases (moderna), which increased only insignificantly in the course. These results of the approval studies are obviously in the area of statistical chance. By dissolving the control groups, the manufacturers also robbed the approval studies of their meaningfulness as early as December 2020. In addition, neither at the time of the initial approval nor to date have there been any clinical studies that could serve as reliable evidence of medium- and long-term effectiveness and safety. On the contrary: initial animal studies in the approval dossiers had even shown clear indications of significant risks.

### Approval for pregnant women despite clear risk warnings

Solid studies that have proven the safety of the new vaccine in pregnant women are still missing. Studies that supposedly prove the safety of this vulnerable group are methodologically insufficient. Even within Swissmedic, the *Human Medicines Expert Committee* explicitly warned of possible risks during pregnancy. The vaccination recommendation for pregnant women is still based on hypotheses and insufficient data.

### Criminal negligence in risk monitoring

To this day, Swissmedic has failed to subject the products that were hastily approved in violation of the minimum legal standards to a consistent and risk-adequate, active product surveillance (so-called pharmacovigilance). As a result, Swissmedic has withheld from the public the assessment bases that are essential for any proper benefit/risk assessment and have accepted the wrong decisions made by healthy people.

### Three vaccination victims representing many

Through the unjustified approval of risky medicines for the entire healthy population, the persons reported have created an increased risk for the healthy population, which has never before emanated from medicines in Switzerland. Unfortunately, this risk has materialized in many people. Representing many, concrete health-damaging effects of the mRNA vaccinations were described by three affected people:

*May Tj (45 years)* had to be hospitalized immediately after the 3rd vaccination. A short time later, the diagnosis was: severe rheumatoid arthritis, along with other symptoms. Since then, the trained clerk has been dependent on a wheelchair and is only able to work 50% of the time. *Rosanna K. (28 years)* Immediately after her 2nd vaccination, she suffered severe episodes of fever, shortness of breath and fainting. For around 6 months she had to be cared for because of chronic fatigue syndrome, fever and diffuse pain and was no longer able to fulfill her duties as a mother and stewardess. *samantha*



K (19) trained in the top ice hockey league until her Pfizer vaccination in January 2021. Immediately after the second vaccination, headaches and loss of concentration set in. She later lost control of her body and suffered from constant spasms all over her body for months.

### **mRNA vaccines: no protection – no vaccination**

At the media conference, Michael Palmer made it clear that how mRNA technology works has never been tested on a large number of people. To date, there is no evidence of a positive benefit from this new technology. The mRNA vaccination not only contains dangerous components, it also produces them itself, including the spike protein. This is distributed in all organs and blood vessels of the body and can lead to blood clots and subsequently to thrombosis, embolism and strokes. Clinical trials in humans started before the potential risks of mRNA vaccinations (eg increased incidence of cancer or DNA damage) had been thoroughly investigated and eliminated in animal studies. The novel mRNA technology is clearly not a vaccination in the strict sense. It lacks the necessary protective effect for this.

### **No influence on the course of the pandemic**

To date, studies on mRNA vaccines have not been able to prove any relevant effectiveness for either mild or severe courses. The high level of effectiveness repeatedly claimed by Swissmedic is based on the so-called Relative Risk Reduction (RRR), which is completely invalidated when the results from the Absolute Risk Reduction are taken into account.

A detailed analysis from August 2022, referenced in the presentation by Prof. Sönnichsen, shows in detail that the mRNA vaccinations have neither positively influenced the course of the pandemic nor prevented deaths. On the contrary: Reliable evidence is growing worldwide that the level of vaccination coverage is associated with an increase in COVID-related deaths and mortality.

### **More and more data on serious vaccine damage**

Never before has a drug been approved with as many serious side effects as mRNA vaccines. Prof. Dr. Martin Haditsch states that mRNA vaccines cause 40 times more deaths per 1 million vaccine doses than flu vaccines. According to figures from the US military database, the mRNA vaccines are leading to a dramatic increase in heart attacks, cancer and neurological diseases. Data from the largest US life insurers show that excess mortality among their policyholders reached a peak in the third quarter of 2021, even exceeding the excess mortality in “pandemic year 2020”. Inflammation of the heart muscle that is exclusively related to COVID-19 is significantly less common than after vaccination.

### **Alarming death rates and declining birth rates in Switzerland:**

Prof. Dr. Konstantin Beck shows that since the introduction of the mRNA vaccinations, the data on excess mortality published by the Federal Statistical Office (BFS) from 2021 were permanently above the BFS expectation maximum, and this more clearly than in the pandemic year 2020. The younger age groups in particular have been significantly above the BFS expectation forecasts since 2021. In Switzerland, since April 2022, there has also been a significant and sustained decline in live births. This is unprecedented in Swiss history. The extent of the decline in the birth rate correlates very clearly with the



Onset of vaccination activity in the younger age groups of the population. However, a correlation with the COVID events or the social restrictions during the pandemic cannot be determined. The observations are consistent with those in the EU and suggest that the mRNA vaccinations are responsible for the decline in births.

**Swiss doctors are too hesitant to report vaccine damage**

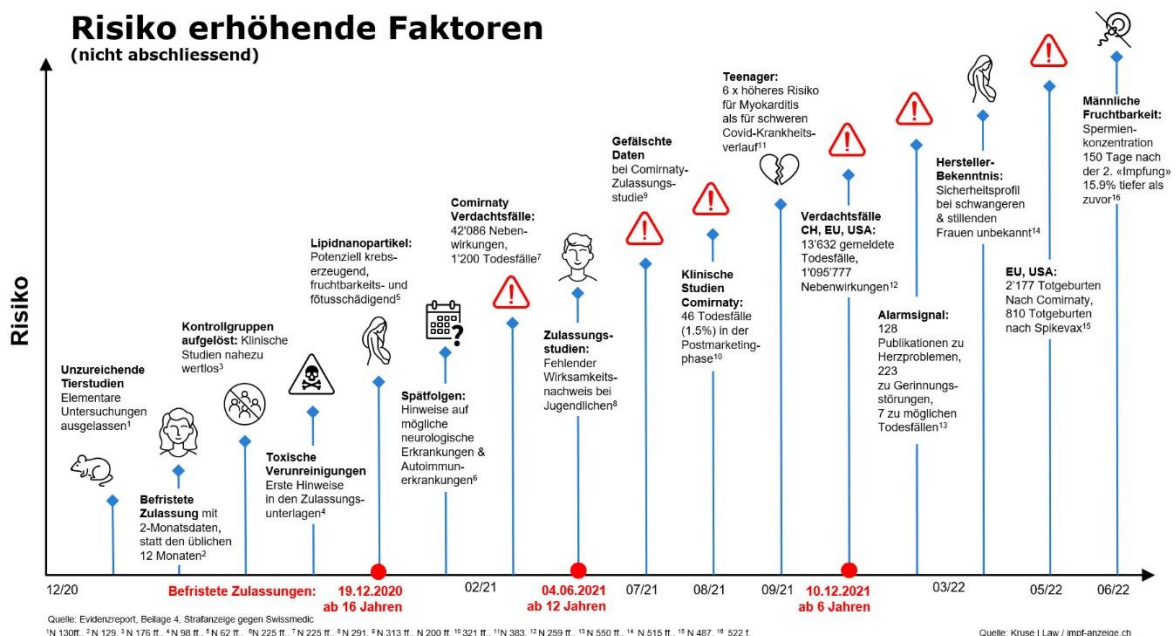
In terms of product monitoring of side effects, Switzerland ranked 17th in a European comparison of reporting rates. It is therefore at the lower end of the intra-European comparison, which indicates an alarming underreporting. The lack of incentives for physicians to report vaccine damage falsifies the picture and contributes to the fact that the problem of side effects has so far hardly been noticed by the public.

**First cantonal criminal proceedings opened against a doctor**

The cantonal public prosecutor called has already opened proceedings against vaccinating doctors due to the facts relevant to criminal law. In accordance with Art. 26 HMG, any medical vaccination must be preceded by proper and complete information about the procedure, its benefits and the possible risks. In addition, there are special information requirements for therapies that have been approved for a limited period of time, including mRNA vaccines. Furthermore, the patient must be informed if not all risks and side effects are known for the new therapies because there are no long-term studies. The plaintiffs affected claim that they were not properly informed.

**Accumulation of ignored risks**

The minimum legal requirements for the approval of these novel mRNA vaccines were never met. From a criminal law point of view, the fact that Swissmedic has extended the approvals to more and more groups of the population, despite warning signals constantly coming in, is particularly serious:





**Despite all of the risk-increasing factors, Swissmedic has done nothing to take adequate measures to reduce the health risks:**no improvement in pharmacovigilance; no improvement in public education; insufficient requirements for manufacturers; no restrictions on previously granted approvals, etc. As a result of this and the larger number of possible victims of vaccination side effects with each approval extension, the responsible persons at Swissmedic have confirmed the previous breaches of duty and have continuously increased the extent of their criminally relevant guilt.

### **Unacceptable procrastination with serious consequences**

**The temporary approval of the mRNA vaccines has all the characteristics of an experiment on humans - but with the special feature that the participants have not been correctly informed about the experimental nature to this day.** This poses an acute threat to public health. The threat affects a healthy population, most of which is not life-threatening from the SARS-CoV-2 pathogen. Every aspect of the criminally relevant serious allegations would have to lead to a criminal investigation and a suspension of the license. Nevertheless, the authorities do not intervene. This delay leads to further damage to individuals and to society as a whole.

For this reason, the undersigned lawyers feel compelled to publish their criminal complaint of July 14, 2022 with all the results of the investigation to protect public health, combined with the following demands:

- immediate opening of criminal proceedings against the responsible persons at Swissmedic;
- immediate suspension of approval of all mRNA vaccines;
- Prompt and truthful information of the public about all decision-relevant facts for the assessment of the risk/benefit ratio of mRNA vaccines.
- Enforcement of an effective system for recording side effects of vaccination.
